

INFORMATION PURSUANT TO EU REGULATION 2016/679 FOR CUSTOMERS USING THE QUALITANDO SERVICE

In accordance with Article 13 of EU Regulation 2016/679 (hereinafter known as "Regulation"); Poseidon Thermal Gardens s.a.s. with headquarters in Via Giovanni Mazzella SNC - 80075 Forio (NA), the data controller, informs you that the processing of your personal data (e-mail address) is carried out to:

- A. allow you access to the park's WiFi,
- B. send you communications aimed at detecting your degree of satisfaction with services, request information about travel and/or leisure preferences, and to inform you of new initiatives and offers on products and services of the Proprietor.

The provision of data to access the WiFi service is required and in its absence we could not guarantee the requested service, the provision of data for the other purposes indicated is optional, and in its absence we could not pursue the aforementioned purposes. The legal basis for processing the user's personal data for the purposes referred to in point A is the contract (service requested by the user). The legal basis of the processing for the activities referred to in point B is the consent of the person concerned. In relation to the latter, the user has the right to withdraw consent at any time. Withdrawal of consent does not affect the lawfulness of any processing based on the consent you provided prior to the withdrawal.

The personal data provided for the purposes referred to in point A shall be kept for the time necessary to provide the service; the data processed for the purposes referred to in point B shall be kept for 24 months. The data, which will not be disclosed, may be communicated to third-party
