right to withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

Your personal data will be processed for the duration of the performance of the requested service and subsequently will be retained to comply with the obligations established by accounting and tax legislation. Personal data processed for the purposes referred to in paragraph 2 will be stored for 24 months from the date of the last communication.

The data will not be disclosed, but it may be communicated to persons who, on behalf of the Data Controller, perform accounting and tax management activities; to third-party companies that carry out activities instrumental to the realization of the aforementioned purposes for the Data Controller and to persons to whom the right to access the data is recognized by law and/or secondary legislation.
