

## PARKING REGULATIONS

This unattended parking service is provided under the following conditions and with the application of tariffs on public display. Entry of the vehicle into the parking area implies full acceptance of these Regulations and associated parking fees.

1. Once the vehicle (car, motorcycle or scooter) enters the privately-owned area, the owner/driver accepts all the conditions of these Regulations, having examined them before entering the area.
2. Upon entering the area, through the appropriate entrances, vehicles must follow the corresponding directions for transit, on display at the entrances, and the daily parking charge must be paid at the cash desks located at the entrances to the parking area.
3. The payment receipt must be kept and shown in the vehicle until the end of your stay. **It is not allowed to reserve parking spaces once leaving the car park.**
4. Possession **of admission tickets to the thermal park and/or the bathing establishment** (tickets/subscriptions) does not entitle the applicant to be allocated reserved parking spaces and does not bind Giardini Poseidon Terme to guarantee the availability of any parking spaces for the applicant.
5. Vehicles must leave the parking area via the appropriate exits.
6. Entry to the parking area entitles the owner/driver of the vehicle to use only a portion of the area specifically defined for placement of their vehicle: **Giardini Poseidon Terme Park**

**assumes no obligations regarding the safekeeping, surveillance, control** of parked vehicles and/or of the things contained in them, and/or the circulation of vehicles, protection and safeguarding of people, animals and/or objects, including parked vehicles.

7. Access to the parking area with purchase of a ticket entitles the holder to use the space occupied by the vehicle, only for that day and only during the hours that the Park is open to the public.
8. Inside the parking area **the rules governing the movement of vehicles must be observed**, therefore the driver of the vehicle, when driving through entrances and exits, within the parking area and the transit lanes, must respect the signs and markings and not exceed the speed limits, indicated on the relevant signs, and, in any case, must drive in such a way to not cause risks or hazards to the safety of people, things and/or animals.
9. The parking of vehicles in the appropriate places must be done in such a way as not to create hindrances, obstacles, or make it difficult for other drivers to manoeuvre, and/or not to impede access and movement of emergency or service vehicles.
10. Users must leave the vehicle locked with the handbrake on.
11. Giardini Poseidon Terme staff, even if present within the parking area, or close to it, has no control over the internal and/or external circulation of traffic, which is the sole responsibility of vehicle drivers and/or owners. **The staff members** present are there exclusively to assist, where necessary, in the correct placement of vehicles in designated parking areas, and **are not responsible for the surveillance, control and/or safekeeping of vehicles**.
12. Giardini Poseidon Terme Park does not exercise any control of the parking area through the use of cameras or other detection and surveillance devices.
13. It is absolutely prohibited to park:
  - outside the specially marked spaces;

- in such a way that the vehicle is outside, even partially, the lines of the individually marked spaces;
- in such a way that creates an obstacle for drivers and/or passengers getting in and/or out of other parked vehicles;
- creating an obstacle for traffic around the emergency exits;
- on pedestrian walkways;
- in disabled parking bays without the necessary accreditation;
- in areas where parking is forbidden or reserved;
- near to the entrances and/or exits;
- on traffic circulation routes.

14. All users are strictly forbidden to:

- unload and store any kinds of articles, particularly if flammable;
- leave in the parked vehicle: animals, flammable and/or toxic substances and materials, and/or other objects, the presence of which may be hazardous;
- carry out refueling, perform repairs, wash the vehicle, recharge batteries;
- light fires, use materials, containers and/or products that may catch fire and/or explode;
- hinder, in any way, the operation of the services, the use of the facilities and installed equipment.

15. The parking tariffs are on public display at the entrances, at the cash desks of Giardini Poseidon Terme Park.

16. The simultaneous passage of two vehicles can result in damage to the vehicles, to people and/or things, including the automatic equipment of the parking area: in which case users will be responsible for any consequential damages.
17. Disclaimer: The parking area is unattended and is not under control and/or surveillance. Giardini Poseidon Terme will not be held liable for vehicle theft, damage caused by third parties to the parked vehicles, theft of objects and/or accessories left in vehicles, or related damages, and is therefore not responsible for the damage or theft of vehicles, executed or attempted, citing by way of example but not limited to:
  - a. theft and/or damage to the parked vehicle, even partial, or to objects in it, caused by third parties, or for any acts of vandalism, natural disasters or cases of force majeure.
  - b. damages due to knocks, collisions and accidents caused by users within the parking lot; the right to compensation for damage must be exercised by the injured party in direct relation to the user that has caused the damage, and Giardini Poseidon Terme Park will not be held liable under any circumstances whatsoever. The user is liable for any damages that they have caused to the facilities, parking staff and/or third parties.

Please note that lockers are available at Guest Services in Giardini Poseidon Terme Park for storage of personal items: therefore Visitors are requested not to leave on board the vehicle, in any way, valuables such as, by way of example: mobile phones, glasses, pens, keys and remote controls for homes, appliances and audio and video equipment, satellite navigation systems, cash or similar, items of clothing and anything else that does not strictly belong to the vehicle itself.
